CITY OF MIRAMAR NOTICE OF FUNDING AVAILABILITY FOR STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) PROGRAM FISCAL YEAR 2023-2024

The City of Miramar announces the availability of approximately \$1,427,000 in SHIP funding for the following programs:

Housing Rehabilitation Program

Provides a deferred loan assistance, up to \$70,000, to households to correct building code violations, make barrier-free modifications, install hurricane protection, address weatherization improvements, promote energy efficiency/conservation and address other minor home repairs to owner-occupied properties in the City. Available to very-low, low, and moderate-income households up to 120% AMI. Priorities given to households with special needs, 80% AMI and below households, and very low to low- income households.

Down Payment/Closing Cost Assistance Program

Purchase Assistance funds will be made available to income eligible very low and low- income first time homebuyers with the goal of expanding homeownership opportunities to the identified targeted income groups. A maximum deferred payment loan up to \$90,000 (very-low, low- income, and moderate income) applicants is applied towards the closing costs, first mortgage reduction, and/or down payment assistance for the purchase of eligible owner-occupied housing.

Foreclosure Prevention Program

The Foreclosure prevention program provides qualified homeowners the opportunity to avoid foreclosures and retain their homes. The program is designed to assist households that need immediate financial assistance to either stop their homes from being foreclosed or sold for non-payment of mortgage and/or assessments. The maximum deferred loan award amount is \$10,000. Evidence that mortgage or fees is more than 60-90 days late is required and reflected by the most current mortgage statement or applicable statement. Properties with Lis Pendens are not eligible.
